

Quick Guide Health-related Product Declarations

This quick guide gives an overview of the most important product declarations related to customer health as relevant to our business operations.

These are the Declare Label and Health Product Declarations (HPD).

Declare Label

The Declare Label, initiated by the [International Living Future Institute \(ILFI\)](#), is like a nutritional facts label for the building industry. It lists all building materials, i. e. "ingredients", to enable the customer to choose the "healthiest" products for their building's interior.

The label informs about product origin, materials used and recycling. The ILFI offers a transparent product database that enables building industry stakeholders to find products that are free from hazardous materials. Hazardous are materials used in the building industry that give reason for concern. Those pollute the environment and can accumulate to toxic concentrations which can be damaging to workers' health. Those materials are summarized in the so-called „Red List“.

Declare Labels that achieve „Red List Free“ status meet the highest disclosure requirements of Living Building Challenge, LBC (Declare program owner) and do not contain any materials listed on the „Red List“.

The Declare Label is recognized by the green building certification system Leadership in Energy and Environmental Design (LEED).

Health Product Declaration (HPD)

An HPD is a product declaration which shows detailed listings of materials and contents of a given building product and related effects on human health, whereby it is assessed if particularly concerning chemicals are contained in the products. HPDs were developed by [HPD Collaborative](#) with a view on appraising potential health hazards of materials. This standard offers a coherent reporting format, in which quality and availability of product and health information is assessed.

HPDs are self-declared. They are a globally recognized industry standard, which are requested by investors, architects, planners and building management companies.

HPDs thus emphasize the manufacturer's commitment to disclose product information in a transparent manner. HPDs are also recognized by the green building certification system LEED.

The HPDs as well as the Declare Labels are used by major North American architectural and engineering firms as the basis for tenders and specifications to design sustainable buildings all over the world.
